

USE OF RAMPS - ALL BREEDS

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required. The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on a ramp through all levels of competition: Lagotto Romagnolo, Nova Scotia Duck Tolling Retrievers, American Water Spaniels, Clumber Spaniels, English Springer Spaniels, Field Spaniels, Welsh Springer Spaniels, Grand Basset Griffon Vendeen, Standard Schnauzers, American Staffordshire Terriers, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Keeshonden, Entlebucher Mountain Dogs, Finnish Lapphunds, Icelandic Sheepdogs, Norwegian Buhunds, Polish Lowland Sheepdogs, Spanish Water Dogs, and Norrbottenspets (Misc.).

At the discretion of the judge through all levels of competition, the following breeds may be judged on the ground, a ramp, or on a table: Boykin Spaniels and Whippets.

At the discretion of the judge through all levels of competition, the following breeds may be judged on a ramp, or on a table: Mudi.

The following breeds must be judged on a ramp through all levels of conformation competition: Sussex Spaniels, Basset Hounds, Cirneco dell'Etnas, Bulldogs, Chinese Shar-Pei and Chow Chows.

This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4–6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions. Ramps can be used in emergency situation to judge any breed.

In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund. For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds. (06/2020)

JUNIOR SHOWMANSHIP COMPETITION

- **NOVICE CLASS:** This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class.
- **OPEN CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.
- MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.
- **NOVICE AND OPEN CLASS DIVIDED:** Junior-9 years old and under 12 years old on the day of the show; Intermediate-12 years old and under 15 years old on the day of the show; Senior-15 years old and under 18 years old on the day of the show.

After the judge has awarded the Best Junior Handler, the second place winner from the class that the Junior was awarded Best Junior Handler is to return to the ring to compete for Reserve Best Junior Handler.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

COVID-19 (CORONAVIRUS) SOCIAL DISTANCING PLAN OLYMPIC KENNEL CLUB, INC.

Washington State Governor Jay Inslee has signed into effect a 4 Phase plan for returning the State of Washington to normal activity. In order for the Olympic Kennel Club, Inc. to hold its annual All Breed Dog Show and the Specialty Shows in conjunctions with it, the state (and King County or the City of Enumclaw) must be in the Safe Start Phase 4 phase of this plan.

Phase 4 states that if the COVID-19 disease burden stays low and the four capabilities (healthcare system readiness; testing capacity and availability; case and contact investigations; and ability to protect high-risk populations) are met, the governor will issue an order for the state to move into Phase 4. All components of phases 1, 2 and 3 will carry into the start of Phase 4 which would be a full return to public interactions (with appropriate physical distancing).

- 1. High risk populations could resume public interactions with physical distancing.
- 2. All recreational activity would resume.
- 3. Gatherings (social, spiritual) in excess of 50 people would resume.
- 4. Businesses and employers of nightclubs, concert venues, and large sporting events would resume unrestricted staffing of worksites, but continue to practice physical distancing and good hygiene.

Based on the above current outline by Governor Inslee, the following plan is designated at this time for the Olympic Kennel Club Inc. All Breed Dog Show, Participating Breed and Group Club Specialty Shows, Agility, Obedience, Rally, Barn Hunt, Lure Coursing, and Dock Diving. (This plan is subject to change as the details outlined above change.)

- IF YOU ARE ILL, FEEL UNWELL, COUGHING, SNEEZING OR RUNNING A TEMPERATURE: Please stay home.
- EXPOSURE TO COVID-19: If you have recently been in the presence of a person who has either tested positive for Covid-19 or has the symptoms (coughing/sneezing/temperature) please stay home.
- 3. OBEDIENCE & RALLY RINGS: To minimize the number of persons near the rings at any one time, be aware of and adhere to your scheduled times. Do not arrive at your designated location more than 15 minutes prior to your scheduled time and exit the area upon completion of your participation. Do not congregate or block ring entrances and exits.
- **4. STAGING AREA:** A designated staging area will be provided for Obedience and Rally. Please remain in this area and maintain social distancing until your number is called to the ring.
- 5. ARM BANDS: At the present time the plan is to issue armbands by group. Tables will be established for each of the 7 groups and the armbands are to be collected at the designated table well before your show time and no later than 1 hour prior to your scheduled show time. Please know your Armband Number when you arrive at the table (and try to remember it until you actually get the armband). Arrange to pick up all armbands at the same time and if possible arrange for one individual to collect the armbands for various individuals. Maintain social distancing while waiting for your armbands. Catalogs at these tables will not be available for your use, but only the use of the individuals assigned to issue the armbands. If you need to label the armbands for particular dogs, please bring your own pen as pens will not be available for use.
- **6. RINGSIDE CHAIRS:** OKC will not provide for any seating around rings. Exhibitors can bring their own chairs but must maintain social distancing between each other and from the rings. Household units are free to sit together. No group gatherings or congregating in the buildings or ringside. Chairs may be left at the ring if desired, at the risk of the owners.
- 7. MASKS: Stewards and Judges will wear masks if possible. Judges will have hand sanitizer and/or gloves available between examinations. All Show Days Judges & Exhibitors are required to wear a mask while the individual exam of the dog is taking place. Failure of exhibitors to adhere to this policy could cause them to be excused from the ring, and may result in disciplinary action.

- 8. RING TENTS: The OKC tents at ringside are meant for the use of the breed scheduled for the ring during that time. Do not arrive at your assigned ring any earlier than 15 minutes prior to your assigned time. In order to maintain social distancing tent space should be yielded to the breed currently in the ring. Please vacate the OKC ring tents as you complete showing in your designated class, unless you will be returning to the ring for "winners" or "breed". Crates are discouraged under these tents but if you do bring a crate for multiple dogs, they must be removed when you complete showing in your class.
- 9. ENTRY TO THE RINGS: Exhibitors will line up outside the ring maintaining social distancing and will be called into the ring as each judge deems appropriate. The judge will direct you as to how to prepare your dog for exam. All Show Days Judges & Exhibitors are required to wear a mask while the individual exam of the dog is taking place. Failure of exhibitors to adhere to this policy could cause them to be excused from the ring, and may result in disciplinary action. Follow the judge's directions. When gaiting with other exhibitors, maintain a distance between exhibits. After placements are made, leave the ring and if you are not going forward in the judging of that breed, please leave the ring and tented area. There will be a separate entrance and exit for each ring, please use these appropriately. The judge or steward will direct those who are going forward as to where they are to wait for winners or BOB judging.
- 10. GROOMING: Depending on State and CDC recommendations at the time of the Show, there may be limitations on the use of blow dryers in the grooming buildings. Grooming space in the grooming buildings may be limited as a need for social distancing and may require spacing between spots.

ATTENTION EXHIBITORS

The Show Site will be available to exhibitors at 2:00PM, Tuesday, August 11, 2020. Dogs must be removed from the show site immediately following Best in Show judging on Sunday, August 16, 2020.

LOADING & UNLOADING - Reserved Grooming will be in the Livestock Building located at the northeast corner of the grounds. Access to the Livestock Building will be off 284th Ave SE - follow signs.

POWER OUTLETS - Use of ALL power outlets is at user's own risk.

No practicing allowed in rings at any time.

No dogs to be left overnight in Reserved or Non-Reserved grooming buildings.

Free Day Grooming is available on a first come, first served basis & is located in the Horse Barn. All equipment must be removed at the end of each day.

Each exhibitor is responsible for cleaning up after his own dog(s). Poop bags will be placed around the show grounds for your convenience. If your dog soils in the show ring, the ring steward will hold your dog while YOU do the clean up. Poop bags will be placed outside each ring. Responsible dog owners will clean up after their dog(s).

All stand-alone ex-pens MUST have someone in attendence with them at all times.

DUE TO COVID-19 GUIDELINES, THE PUBLIC IS NOT INVITED TO ATTEND THESE EVENTS.

Non-Regular Classes Involving Single Dog Entries

A class for Dogs and a class for Bitches, 7 years of age and older. Dogs/bitches entered in Veterans must be intact. Winners, if otherwise undefeated, are eligible for Best of Breed competition.

BEST OF BREED (VARIETY) COMPETITION – The following categories of dogs may be entered and shown in Best of Breed (Variety) Competition: Dogs that are Champions of Record and dogs which according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed champions in Best of Breed (Variety) Competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship. Selects, if applicable, will be chosen following Best of Breed.

NON-REGULAR CLASSES (INVOLVING MULTIPLE DOG ENTRIES)

Note: Non-regular classes involving multiple entries may be judged before or after Best of Breed. As the judge's decision in these classes will be based on the merits of more than one dog, no one of the dogs making up the entry judged first in the class will be eligible to compete for Best of Breed or Best of Opposite Sex to Best of Breed by virtue of having won the class.

Stud Dog Class and Brood Bitch Class: Each entry is allowed two get unless otherwise specified. The merits of the Stud Dog or Brood Bitch are not considered in the placement of the entry. It is the quality of the get that forms the basis for the judge's decision. All get must be examined and gaited. The Stud Dog or Brood Bitch must also be examined to determine if there is a condition that would require disqualification or excusal under the Rules, AKC policy or the breed standard. All get must be entered in a regular class in order to be eligible to compete in the Stud Dog or Brood Bitch Class. Handlers of the Stud Dog or Brood Bitch, and all get being exhibited, must wear armbands. Ch. 11, Sec. 8 of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."

Brace Class: Two Dogs, performing in unison, and presented by a maximum of two handlers. Both dogs competing in the brace class must have at least one common owner. Dogs do not need to be entered in any other class. Dogs comprising a Brace Class must be named at the time of entry, and full particulars must be given for each dog on individual entry forms. If a dog which is to be part of a Brace is not entered in another class, it must be entered for "Brace Class only." An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for additional classes as "Brace Class."





At every licensed or member club rally trial, a recording fee of \$3.50 is required for the first entry of each dog and a recording fee of \$3.00 is required for each additional entry of the same dog.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned
 entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry
 Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes
 no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's
 agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. BaRay Events will add a \$30.00 collection fee to the
 amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send
 a money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person
 may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed by
 the Club to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all

- Females in season are not permitted to compete in Obedience or Rally Trials. The Clubs may retain a processing fee and must publish this information in the premium. Clubs may determine the documentation, if any that is required to confirm the female is in season. This shall be stated in the premium. Note: No fee is paid to the AKC for females in season who are withdrawn.
- FAX ENTRIES Fax entries will be accepted up to closing time. Fee is \$4.00 per dog per show. If the credit card
 charge is denied for any reason, an additional service charge of \$20.00 will be added. FAX NUMBER: 360-7552248. This is for Fax Machine ONLY. Incomplete or illegible Fax entries are not acceptable as a valid entry in a

- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge
 or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered

 or other acts beyond the control of the management it is impossible to open, or to complete the Show NO

 exhibitors to be responsible guests. A report that an exhibitor at this show has abused hotel or motel property
 during this weekend may result in disciplinary action. Clubs reserve the right to decline future entries from the
 offending party in accordance with the provisions of Chapter 11, Section 15 of the Rules Applying to Dog Shows.
- Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs
 must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any
 service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding
 up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.
- Only dogs eligible for these shows will be admitted into the show area. There is no provision for unentered dogs.
- LOSS OR DAMAGE The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, clubs should include any specific local health requirements; for example proof of rabies vaccination.
